Domestic Secondary Data Resources Utilization in Healthcare Research

Introduction

The secondary data resource means the data collected for the purpose other than specific studies. The studies using these secondary data resource may have limitations in securing the research results compared to the primary resource studies which directly collect data for certain studies. However, the secondary source studies may contain subjects hard to join studies due to illiteracy and poor health conditions considered as disadvantages of the studies, draw effective conclusions with less cost and time, as well as the reduced possibility for biased recollection and selective report compared to the primary source studies, increasing the requirement.

However, the current situation shows that researchers fail to aggressively utilize due to not providing systematic data for the status and features of the data sources even though various local organizations produce high quality secondary sources from various sectors.

Objective

The purpose of this manual is to establish the list of secondary data resources available in studies related to local healthcare and provide basic information for planning researches. In addition, the manual provides in-depth information including self-examination list and analysis of sample researches for researchers to perform effective and reasonable studies by utilizing the data in the planning or analysis process.

Methods

The study reviewed data sources including statistical lists from affiliated organizations of the Statistics Korea(central government agencies, research bodies, public corporation, etc), statistics portal of the Ministry of Health and Welfare(health and welfare statistics) and related organizations to understand the status of the secondary sources from local health organizations. The study selected the secondary sources to be included in the manual by reviewing the possibility for providing micro data with the unit of person and including the examination items through websites or hands-on people for statistical production or announcing organizations.

The study collected basic information(purpose, system and item of the data and procedure for data provision) referring to websites, guideline for using the raw data and published reports from selected data sources and provided cautions as tips to prevent errors for the data analysis.

In addition, the study proposed summarized table by mapping major items examined for each data source to provide more effective information while reviewing proper secondary sources for the study purpose and proposed self-examination table for

items to be considered for planning studies using the secondary data resources developed through prior studies in 2011. Lastly, the study described the data collection method through complicated sample design based on the results of the Korea National Health and Nutrition Examination Survey and mentioned weighting factors to be considered in the data analysis using these sample data.

The finally selected 22 basic information in the secondary sources are as follows(Table 3). Please refer to the specific contents of 'NECA Research-Method Series 5: Domestic Secondary Data Resources Utilization in Healthcare Research' to be published for the sample data analysis considering self-examination table, mapping results for each data source and complicated sample design on specific data for the purpose and system of data collection for each data source, variable list, procedure for data provision and tips, as well as secondary data resources.
